Police whatsapp Account / other electronic media.

It is requested for the detailed guidelines in this regard.

The details of the same is placed as per "Flag-A" for kind perusal, please.

In this regard, it is to submit that in the meeting dated: 22.07.2023 at Bhopal the following was resolved as under:-

- a) Serving of Photos/PDF of summons and warrants electronically through "WhatsApp Business Account" of Madhya Pradesh Police or any other electronic media is to be treated as serving as physical forms. In this regard, the Principal Secretary, Law & Legislative Affairs Department to provide the detailed guidelines***

regarding implementation of the same and to process the matter at the earliest.

b) A provision should be made in the CCTNS to enter the non-CUG WhatsApp number of the IO and the WhatsApp number of all other witnesses (including doctors, FSL officers etc.) who are part of the investigation; so as to ensure that the digitally generated e-Summons are directly served to them on their WhatsApp numbers as well.

c) "Whatsapp as a service" is to be developed by MPSEDC for the High Court of Madhya Pradesh, Jabalpur meeting out the requirement of the High Court

In this regard, it is to submit that the matter may be placed before the I.T. and e-Courts Committee of the High Court regarding to prepare detailed guidelines for serving of summons warrants through M.P. Police whatsapp Account / other electronic media.

- g) Proposal for including ICJS portal usage in the basic syllabus in Judicial academy also the capsule course of ICJS system is to be developed and to be distributed to all stakeholders.*
- h) State level one day or two days workshop on ICJS system to be conducted at Bhopal and in the workshop the representatives of all pillars of ICJS are to be invited. The ACS, Home to take the initiative for this workshop.*
- i) The project of serving of summons / warrants is to be implemented through system software and the task is to be completed by 30th July, 2023 at District Khandwa under pilot phase. Thereafter, the project of serving of summons / warrants is to be carried out for remaining Districts of Madhya Pradesh.*
- j) Serving of Photos/PDF of summons and warrants electronically through "WhatsApp Business Account" of Madhya Pradesh Police or any other electronic mediais to be treated as serving as physical forms. In this regard, the Principal Secretary, Law & Legislative Affairs Department to provide the detailed guidelines regarding implementation of the same and to process the matter at the earliest.*
- k) A provision should be made in the CCTNS to enter the non-CUG WhatsApp number of the IO and the WhatsApp number of all other witnesses (including doctors, FSL officers etc.) who are part of the investigation; so as to ensure that the digitally generated e-Summons are directly served to them on their WhatsApp numbers as well.*



is requirement of dump database of District Courts, so that dashboard can be completed with entire database.

In this regard, the following was discussed and resolved in the meeting *dated: 22nd July, 2023* at Bhopal as under:-

- a) *The complete database dump of High Court and District Courts is to be provided in a secured manner to MPSEDC and MPSEDC will use the database as per requirement for the development of dashboard.*
- b) *The Principal Secretary, Law & Legislative Affairs Department, Govt. of M.P. and Managing Director, Madhya Pradesh State Electronics Development Corporation to coordinate regularly in order to impart training on continuous basis to all respective stakeholders.*
- c) *Managing Director, Madhya Pradesh State Electronic Development and SIO, NIC, Bhopal to coordinate with various Departments regarding Integration of open API with various Departments and to impart the training regarding usage of dashboard accordingly.*
- d) *The AI System to be implemented by MPSEDC in the dashboard for tracking of cases.*
- e) *"Whatsapp as a service" is to be developed by MPSEDC for the High Court of Madhya Pradesh, Jabalpur meeting out the requirement of the High Court.*
