

Subject:- PUD e-mail dated: 18.12.2023 of Registrar General, High Court of Orissa Cuttack regarding secure backup of digitized data of the High Court of Orissa in a suitable no-seismic / low seismic zone outside the State of Odisha.

Under the subject cited above, it is to submit that the communication has been received from Registrar General, High Court of Orissa: Cuttack that digitization of legacy records of the High Court of Orissa as well as of the District Courts of the State of Odisha is being undertaken in a full-fledged manner. Owing to the vast amount of digitized data being generated in the process, it is felt necessary that all such data be stored in a secure Data Centre/Location outside of the State of Odisha since it lies in a seismic zone.

It is further intimated that in due process of selecting appropriate location(s) for the above purpose, this Hon'ble Court has identified the State of Madhya Pradesh as a suitable and secure choice due to its presence in a non- seismic/low seismic zone. The transmission of data shall be made periodically, preferably, on a monthly basis, which shall be stored in a secure Server wherein itself will also serve as a backup to facilitate Disaster Recovery Management.

It is therefore requested your good self to kindly intimate the undersigned regarding feasibility of the provision of secure storage of digitized data of Odisha Judiciary in a Server in Your esteemed High Court or any other suitable Data Centre under your jurisdiction. Also, it is requested to kindly intimate regarding any financial implications in the said matter which may be met at our end in order to expedite the above exercise.

Upon receiving the proposal from your end, the High Court of Orissa shall consider to extend the provision of maintaining data

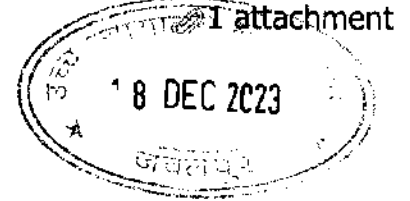
